Create New Assessment: Assessment Questionnaire Submission Guide

- This self-assessment is **organised into sections**, with each section prompting you to **input specific information** based on your current business operations. Each section corresponds to one of the **18 OPERI dimensions**, covering different aspects of **business operational excellence**. There are **no right or wrong answers**—your task is to provide as much **specificity and detail as possible**. The more detailed your responses, the better the system can understand your business and accurately assess which **band** you belong to for each dimension. Providing vague or minimal input may result in a less precise assessment.
- **Progression Through the Assessment:** As you complete each section, the system will determine your band for that OPERI dimension based on your responses. You will then move on to the next section.
- **Video Insights:** After completing a section, a video will appear reflecting your **progress across bands**. However, if you are placed in **Band 0 for any dimension, no video will be shown, and you will automatically proceed to the next section.**



Step 8

Upon completion of the questionnaire, you will receive the following

- 1. OPERI Emblem:** This provides an instant visual representation of your company's score, ranging from 0 to 5. The Emblem is only provided if a Certified OPERI Assessor (COA) is attached to your OPERI assessment, or you can request one upon assessment completion. Your responses will be reviewed to determine eligibility. If an Emblem is declined, you cannot request it again.
- 2. Assessment Report:** This report summarises your company's performance, highlighting strengths and weaknesses, and provides a transformation roadmap outlining what to prioritise next for achieving operational excellence.
- 3. Band Transition:** This section details the next steps and provides guidance on how to progress to the next stage of your operational excellence journey.
